# Executive summary

# Foreword

The macroeconomic environment in Europe continues to be shaped by various factors, including interest rates, inflation, and geopolitical risks. These factors have implications for the consumer markets and the wider deals landscape.

Geopolitical tensions in the Middle East are recently further increasing, adding to the overall uncertainty. In Europe the 2024 super-election year continues, with several elections taking place in autumn, i.e., in Austria and Lithuania. We also continue to observe the presidential election campaigns in the USA, which will no doubt impact global geopolitics and economic developments.

Against this backdrop, it is crucial for businesses to closely monitor the macroeconomic developments and adapt their strategies accordingly. Understanding the impact of interest rates, inflation, and geopolitical risks on consumer behavior and market trends is essential for identifying opportunities in the deals market.

For M&A, deal activity in August involved 102 deals in total; that's an increase of 61 deals year on year. A couple of the notable ones are:

- Pandox AB acquired three Residence Inn by Marriott Hotels
- Waterland Private Equity Investments BV acquired a majority stake in X<sup>2</sup>O

- De Groot Edelgebak BV was acquired by Europastry SA
- Droste BV was acquired by Pauwels Engineering

The most active sector (in number of deals) in August was Sports & Recreation with 12 deals, as shown by (1) You Jump acquiring Jumpsquare, (2) D-Marin acquiring Porto Mirabello, and (3) Brewery On Chiswell Street Ltd being acquired by Rhubarb Food Design Ltd and Oak View Group LLC.

Several potential acquisitions and exits are also being explored. To name a few:

- Delta Wines, the Navitas Capital-backed Dutch wine importer and distributor, is viewed as a candidate that may hit the market soon
- A stake in Zip World, a UK-based activity site operator, is understood to have been put up for sale by the private equity firm LDC
- Wingstop UK, the UK franchise of the Wingstop Inc fast food restaurant chain, has been put up for sale with Goldman Sachs as advisor
- Unilever has hired PwC to gauge interest in a sale of the Kate Somerville skincare brand

We hope you find this newsletter useful in quickly bringing you up to speed on recent Consumer Market M&A activity.


# **Recent Retail, Consumer and Leisure deals**

Bankruptcy declarations in the EU have been on the rise since the end of the Covid pandemic. Bringing the number of bankruptcies back to more normal levels compared to the pre-pandemic levels and even beyond to their highest level since 2018, both across the board and in wholesale and retail. This indicates an uptick in businesses facing financial difficulties.


Factors that we have seen causing financial difficulties are persistent inflation, supply chain issues, but also the repayment of COVID-19 support. We see these developments across the market but especially with our consumer market clients. All in all this may lead to an uptick in restructuring activity in consumer markets.




# Quarterly deal volume by sector (Sep23-Aug24)

Deal volume by investor type




